To rescind this document, you must file a request for rescission with the Clerk of Superior Court and request a hearing before the district court within the time period indicated above. After sixty (60) days have elapsed, execution of this document may be challenged in court only upon the basis of fraud, duress, mistake, or excusable neglect.
